FOR MOST PROGRAMS, STUDENTS ARE ELIGIBLE FOR UP TO \$11,000 PER YEAR IN ASSISTANCE FOR POST-SECONDARY EDUCATION. DURING THE FISCAL YEAR ENDED JUNE 30, 2025, CS PROCESSED NEARLY 2,570 APPLICATIONS AND AWARDED 146 SCHOLARSHIPS TO STUDENTS.
