FOR MOST PROGRAMS, STUDENTS ARE ELIGIBLE FOR UP TO \$10,000 PER YEAR IN ASSISTANCE FOR POST-SECONDARY EDUCATION. DURING THE FISCAL YEAR ENDED JUNE 30, 2019, CS PROCESSED NEARLY 6,000 APPLICATIONS AND AWARDED 224 SCHOLARSHIPS TO STUDENTS.

(EMERGENCY GRANTS) GRANTS FOR URGENT SITUATIONS ARE AVAILABLE FOR STUDENTS ALREADY RECEIVING EDUCATIONAL FUNDING FOR DEGREE PROGRAMS. THESE FUNDS ARE DESIGNATED FOR NON-EDUCATIONAL EXPENSES SUCH AS MEDICAL BILLS, TRANSPORTATION EMERGENCIES, OR REPLACEMENT OF ESSENTIAL BELONGINGS AFTER THEFT OR FIRE. DURING THE FISCAL YEAR ENDING ON JUNE
